Adel Landmarks Limited (hereinafter “ALL” or “Adel”) is a public limited company registered under the provisions of the Companies Act, 2013 having its registered office at B-292, Chandra Kanta Complex, Shop No. 8, Near Metro Pillar No. 161, New Ashok Nagar, New Delhi-110096, India.

ALL is undergoing Corporate Insolvency Resolution Process (“CIRP”) under the provisions of the Insolvency and Bankruptcy Code, 2016 (“IBC” or “Code”), pursuant to Order of the Hon’ble NCLT, Principal Bench dated December 05, 2018. Mr. Udayraj Patwardhan (IP Registration No.: IBBI/IPA-001/IP-P00024/2016-2017/10057) has been appointed as the Resolution Professional (“RP”) of ALL by the Committee of Creditors (“CoC”) of ALL.

As per Order dated September 20, 2019 passed by the Hon’ble NCLAT read with the Order dated November 01, 2019 and December 03, 2019 of the Hon’ble NCLT, the CIRP of Adel and Sachet Infrastructure Private Limited (“Sachet”), Mehak Realtech Private Limited (“Mehak”), Sameeksha Estate Private Limited (“Sameeksha”), Magad Realtors Private Limited (“Magad”) and Jamvant Estates Private Limited (“Jamvant”) shall run as a group insolvency resolution process under the provisions of the IBC. It has further been ordered that the CIRP of Adel, Sachet, Mehak, Sameeksha, Magad and Jamvant shall run in parallel.

Pursuant to Section 25(2) (h) of IBC, read with Regulation 36A of the CIRP Regulation, the RP hereby invites Expression of Interest (“EOI”) from interested and eligible prospective resolution applicants (“PRA”) **for the purpose of submission of Resolution Plan for ALL.**

It is pertinent to mention that ALL is developing multiple projects in various locations in India, wherein ALL has development rights in the land owned by it and many entities, some of which are subsidiaries, associates or related companies of ALL.

The PRA may apply for any or all projects in which Adel has development rights. However, in respect of projects forming part of group companies of Adel undergoing CIRP, separate EOIs shall be required to be submitted for such projects pursuant to invitations issued by the RP of such companies.

## **ELIGIBILITY CRITERIA UNDER SECTION 25 (2) (h) of the CODE**

To be eligible to submit EOI, the PRAs must satisfy the following eligibility criteria, as approved by the CoC in accordance with Section 25 (2) (h) of the Code.

### **A. For PRAs that are Corporates- Private/ Public limited company, LLP, body corporate whether incorporated in India or outside India**

- Minimum Tangible Net Worth (“TNW”) INR. Ten Crore (Rs. 10,00,00,000/-) at the Group Level in the immediately preceding completed financial year or;
- Net Worth shall be computed as aggregate value of paid-up share capital and all reserves created out of the profits and securities premium account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, and does not include capital reserves including reserves created out of revaluation of assets, write back of depreciation and amalgamation.
- For fulfilling the Group criteria, the entities shown as part of Group either must have controlling interest or controlled by or under common control with the PRA. Control means at least 26% ownership. The entities must have been part of the Group for at least 3 years.

### **B. For PRAs that are Financial Investors- Foreign Investment Institutions (FII) / Mutual Funds / Private Equity/ Venture Capital Funds, Domestic/ Foreign Investment institutions, Non-Banking Finance Companies (NBFC), Asset Reconstruction Companies, Banks and similar entities**

- Minimum Asset Under Management (“AUM”) or funds deployed of INR One Hundred Crore (Rs.100,00,00,000/-) in the immediately preceding completed financial year;

### **C. For Consortium**

PRA may be a Consortium. “**Consortium**” shall mean any person acting together with another person as a consortium/joint bidder or joint venture (whether incorporated or not) for the purpose of submission of the EOI and Resolution Plan for the Company.

Lead Member of Consortium Potential Resolution Applicant must satisfy eligibility criteria mentioned in Point “A” or “B” above, as applicable. In addition, Consortium should satisfy requirements set out in paragraph 6 below.

Each PRA, alongwith EOI, is required to furnish an undertaking in the form as set out in Annexure ‘A’ as per the requirement specified under Regulation 36A of the CIRP Regulations.

## **1. DISQUALIFICATION UNDER SECTION 29A OF THE CODE**

Please note that a PRA will not be eligible to submit the EOI if it or any person acting jointly or in concert with it, is disqualified under Section 29A of the Code (as amended from time to time, including extant law/ regulations prevailing at the time of evaluation of eligibility criteria).

In case of a Consortium, each member of the Consortium should be eligible under Section 29A of the Code.

Each PRA, alongwith EOI, is required to furnish an undertaking in the form as set out in **Annexure ‘A’** hereof confirming that it is not disqualified under Section 29A of the Code.

## 2. **REFUNDABLE DEPOSIT/ BANK GUARANTEE**

Along with the EOI, all PRAs shall be required to provide a non-interest bearing refundable deposit by way of Demand Draft/ Bankers Cheque/financial bank guarantee ("FBG" or "BG") or through such other instrument acceptable to the CoC, of INR Ten Lakhs (Rs. 10,00,000/-) ("**Refundable Deposit**")

The Refundable Deposit shall be paid through Demand draft in favour of Adel Landmarks Limited payable at par.

In case of FBG, an unconditional and irrevocable Financial BG from a bank should be issued in favour of Adel Landmarks Limited with validity till twelve (12) months, and to be extended for such additional time period as CoC/RP may decide until the expiry of CIRP. There will also be a 30 days claim period subsequent to last date of FBG, allowed for invocation of the FBG. The FBG must be from a Scheduled Commercial Bank or a financial institution in India. The format of FBG is attached as **Annexure- 'C'**.

The Refundable Deposit shall be refunded (without interest)/ the FBG shall be returned within 30 days of the following:

#### **UNDERTAKING UNDER SECTION 29 OF THE INSOLVENCY AND BANKRUPTCY CODE, 2016 AND REGULATION 36(4) OF THE INSOLVENCY AND BANKRUPTCY BOARD OF INDIA (INSOLVENCY RESOLUTION PROCESS FOR CORPORATE PERSONS) REGULATIONS, 2016 TO MAINTAIN CONFIDENTIALITY**

1. On 05 December, 2018, the Principal Bench of National Company Law Tribunal (“NCLT”) has directed commencement of corporate insolvency resolution process (“CIRP”) against **Adel Landmarks Limited (“ALL”)** under the Insolvency and Bankruptcy Code, 2016 (“IBC”). Mr. Udayraj Patwardhan, a licensed insolvency professional, was appointed as interim resolution professional of Adel Landmarks Limited by the NCLT, Principal Bench by order dated 05 December, 2018. He was later appointed as resolution professional (“**Resolution Professional**”) by the committee of creditors of Adel Landmarks Limited (“CoC”) in its meeting held on \_\_\_\_\_.
2. On passing of the order dated 05 December, the powers of the board of directors of Adel Landmarks Limited stood suspended and the powers of its board of directors now vest in Mr. Udayraj Patwardhan.

3. It is the duty of the Resolution Professional under the IBC to prepare an Information Memorandum (“**IM**”) of the corporate debtor and invite the resolution applicants to submit a resolution plan.
4. Pursuant to the invitation for resolution plans from potential resolution applicants by the Resolution Professional, we are interested in submitting a resolution plan for Adel Landmarks Limited to the Resolution Professional.
5. We require a copy of the IM of Adel Landmarks Limited and other additional information relating to Adel and its subsidiaries that may be necessary to prepare a resolution plan of the Adel Landmarks Limited by us, either directly or through our affiliates, for submission to the Resolution Professional. We note, understand and acknowledge that:
  - (i) You have prepared an IM of Adel Landmarks Limited in terms of Section 29 of the IBC read with the relevant regulations framed under the IBC. We further note and understand that the information contained in the IM is confidential information and can be made available to a resolution applicant only after obtaining an undertaking of confidentiality as required under Section 29 of the IBC and Regulation 36 of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 (“**CIRP Regulations**”) only for the purpose of submitting the resolution plan for Adel Landmarks Limited;
  - (ii) IM is prepared on the basis of information provided by the management of Adel Landmarks Limited and its creditors. No representation or warranty, express or implied, is given by the Resolution Professional or the advisors appointed by the Resolution Professional or any of its partners, directors, officers, affiliates, employees, advisors or agents (unless specifically mentioned under the provisions of the IBC) as to the accuracy or completeness of the contents of this IM or any other document or information supplied, or which may be supplied at any time or any opinions or projections expressed herein or therein;
  - (iii) The IM is a dynamic document and may be updated from time to time till a resolution plan is approved by the CoC;
  - (iv) Other additional information relating to Adel Landmarks Limited and its subsidiary/ related companies may be necessary for preparing the resolution plan collectively and/or severally for each project;
  - (v) Any additional or supplementary information or clarification besides the IM, including those provided by way of emails or on telephone or in meetings provided to us by the Resolution Professional or his team members, including legal advisors are also confidential in nature and shall be construed as a part of the IM.
6. The IM, together with any other information, material, document or clarification provided to us, whether as part of the virtual data room or otherwise, including that provided by way of emails or on telephone or in meetings by the Resolution Professional or his team members, including advisors is referred to as “**Confidential Information**”.
7. We are executing this undertaking of confidentiality to maintain confidentiality in respect of the Confidential Information as mandated by the IBC and CIRP Regulations.
8. In terms of Section 29 of the IBC and Regulation 36 of the CIRP Regulations we unconditionally and irrevocably agree and undertake:

- (i) to maintain confidentiality of the Confidential Information and not to use such Confidential Information to cause an undue gain or undue loss to ourselves or any other person.
  - (ii) in terms of Section 29(2) of the IBC, to
    - (a) comply with provisions of law for time being in force relating to confidentiality and insider trading in relation to such Confidential Information;
    - (b) protect any intellectual property Adel Landmarks Limited and its subsidiary/ related companies which we may have access to;
    - (c) not share this information with any third party unless it is shared on a strict need-to-know basis and clauses (a) and (b) above are complied with;
  - (iii) Except as provided herein, we will not disclose the contents of Confidential Information, as updated from time to time, to any person other than to our affiliates, including, for avoidance of any doubt, our and their directors, officers, employees, agents or advisors, including, without limitation, financial advisors, attorneys, bankers, consultants and accountants, and potential financing sources (collectively, our “**Representatives**”) who need to know such information for the purpose of the Transaction, provided that such Representatives are also bound by the same confidentiality obligations as us. We will be solely responsible for any breach of the provisions of this undertaking of confidentiality by any of our Representatives.
9. We accept and acknowledge that the Confidential Information has been developed or obtained by Adel Landmarks Limited through investment of significant time, effort and expense, and that the Confidential Information is valuable, special and unique asset of Adel Landmarks Limited, which provides Adel Landmarks Limited with a significant competitive advantage, and needs to be protected from improper disclosures. We further understand and accept that the information contained in the Confidential Information, as updated from time to time, cannot be used for any purpose other than for the Transaction. Accordingly, we unconditionally and irrevocably agree and undertake to ensure that our Representatives agree to:
- (i) maintain confidentiality of the Confidential Information, as provided from time to time, and not to use such Confidential Information to cause an undue gain to themselves / us or undue loss to any other person including Adel Landmarks Limited or any of its creditors and stakeholders;
  - (ii) keep the Confidential Information safe in a secure place and protected against theft, damage, loss and unauthorized access and undertakes to keep all documents and other materials reproducing or incorporating confidential information separate from its own confidential information;
  - (iii) protect any intellectual property of Adel Landmarks Limited that they may have access to; and
  - (iv) use Confidential Information solely for the purpose of the Transaction and not for any other purpose.
10. Notwithstanding anything to the contrary contained herein, the following information shall however not be construed as Confidential Information:
- (i) information is or becomes publicly available to us or our Representatives without breach of obligations as set out herein; or

- (ii) prior to its disclosure in connection with the Transaction, was already in our or our Representatives' possession (other than such information made available by the Resolution Professional at any time during the CIR process of Adel Landmarks Limited, which information shall be construed as Confidential Information and shall be bound by the terms of this confidentiality undertaking); or
  - (iii) is or has been developed independently by us or our Representatives without reference to or reliance on the Confidential Information disclosed under this undertaking of confidentiality; or
  - (iv) information was or becomes available on a non-confidential basis from a source that is not known by us or our Representatives to be prohibited from disclosing such information by any contractual, legal, or fiduciary obligation; or
  - (v) prior consent by the Resolution Professional is provided for disclosure in writing; or
  - (vi) information that is required to be disclosed by us (to the extent required to be disclosed) by any applicable law for the time being in force or by any applicable regulatory authority or regulation or professional standard or judicial process, order of a judicial, regulatory or administrative authority (including by deposition, interrogatory, request for documents, subpoena, civil investigative demand, or similar process) or the guidelines of regulatory/administrative authority or stock exchange.

Notwithstanding anything stated therein, we are permitted to retain information pursuant to our automatic archiving and back-up procedures; provided however, that the copy/information retained by us shall not be used by us in any manner to cause an undue gain to us or undue loss to any other person including Adel Landmarks Limited or any other company for which the connected resolution is submitted or any of its creditors and stakeholders and shall be bound to the confidentiality obligations under this undertaking.
  14.
