Golden Glow Estates Private Limited (hereinafter “**Golden Glow**”) is a private limited company registered under the provisions of the Companies Act, 2013 having its registered

office at B-292, Chandra Kanta Complex, Shop No. 8, Near Metro Pillar No. 161, New Ashok Nagar, New Delhi-110096, India.

Golden Glow is undergoing Corporate Insolvency Resolution Process (“**CIRP**”) under the provisions of the Insolvency and Bankruptcy Code, 2016 (“**IBC**” or “**Code**”), pursuant to an order of Hon’ble NCLT, New Delhi dated November 27, 2018 (“**NCLT Order**”). Mr. Udayraj Patwardhan (IP Registration No.: IBBI/IPA-001/IP-P00024/2016-2017/10057) (“**RP**”/ “**Resolution Professional**”) has been appointed as the Resolution Professional of Golden Glow by the Committee of Creditors (“**CoC**”).

Pursuant to Section 25(2) (h) of the Code, read with Regulation 36A of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 (“**CIRP Regulations**”), the RP hereby invites Expression of Interest (“**EOI**”) from interested and eligible prospective resolution applicants (“**Potential Resolution Applicant**” or “**PRA**”) **for the purpose of submission of Resolution Plan in respect of the Golden Glow Estates Private Limited.**

It is pertinent to mention that Golden Glow together with Rational Buildcon Private Limited (“Rational Buildcon”) and Digamber Buildcon Private Limited (“Digamber”) are separate owners of land in Sector 68 Gurugram, Haryana, on which **Sky Ville Project** is being developed by Adel Landmarks Limited (“Developer”), their holding company, pursuant to a Collaboration Agreement. The Developer, Rational Buildcon Pvt Ltd and Digamber Buildcon Private Limited are also undergoing CIRP. The RP appointed in Rational Buildcon Pvt Ltd and Digamber Buildcon Private Limited has also issued Invitation for submitting EOI including corresponding right/share in the Sky Ville Project. The eligible prospective resolution applicants (“PRA”) are invited to submit EOI including corresponding right/share in Sky Ville Project in which land is owned by Golden Glow, Rational and Digamber along with the corresponding developing rights of the project held by the Developer.

The prospective resolution applicants will be free to submit EOI for the Developer if they are eligible and interested in acquiring the Developer and its various projects.

Golden Glow, together with, the Developer, Guiding Force Developers Pvt. Ltd, Jamvant Estates Pvt. Ltd. And Influx Realtors Pvt. Ltd. own land in the ‘Aspen Garden Project’ located

in Village Kahudauli, Delhi-Haridwar Bypass, Meerut, Uttar Pradesh, the development rights of which are held by the Developer. Pertinent to mention that application for initiation of Corporate Insolvency resolution process against Jamvant Estates Pvt. Ltd. under the provisions of the Code have been filed and the orders are reserved before the Hon'ble Adjudicating Authority.

It may be noted that a part of the land is also owned by Golden Glow alongwith the other companies as mentioned below in "Aspen Garden Project". The brief particulars of the **Aspen Garden Project** are as under:

ELIGIBILITY CRITERIA UNDER SECTION 25 (2) (h)

To be eligible to submit EOI, the PRAs must satisfy the following eligibility criteria, as approved by the COC in accordance with Section 25 (2) (h) of the Code.

A. For PRAs that are Corporates- Private/ Public limited company, LLP, body corporate whether incorporated in India or outside India

- Minimum Tangible Net Worth (“TNW”) INR 10 crore at the Group Level in the immediately preceding completed financial year or;
- Net Worth shall be computed as aggregate value of paid-up share capital and all reserves created out of the profits and securities premium account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, and does not include capital reserves including reserves created out of revaluation of assets, write back of depreciation and amalgamation.
- For fulfilling the Group criteria, the entities shown as part of Group either must have controlling interest or controlled by or under common control with the PRA. Control means at least 26% ownership. The entities must have been part of the Group for at least 3 years.

B. For PRAs that are Financial Investors- Foreign Investment Institutions (FII) / Mutual Funds / Private Equity/ Venture Capital Funds, Domestic/ Foreign Investment institutions, Non-Banking Finance Companies (NBFC), Asset Reconstruction Companies, Banks and similar entities

Minimum Asset Under Management (“AUM”) or funds deployed of INR 100 crores in the immediately preceding completed financial year;

C. For Consortium

PRA may be a “Consortium”. “**Consortium**” shall mean any person acting together with another person as a consortium/joint bidder or joint venture (whether incorporated or not) for the purpose of submission of the EOI and Resolution Plan for the Company.

Lead Member of Consortium Potential Resolution Applicant must satisfy eligibility criteria mentioned in Point “A” or “B” above, as applicable. In addition, Consortium should satisfy requirements set out in paragraph 6 below.

Each PRA, alongwith EOI, is required to furnish an undertaking in the form as set out in Annexure ‘A’ as per the requirement specified under Regulation 36A of the CIRP Regulations.

1. DISQUALIFICATION UNDER SECTION 29A OF THE CODE

Please note that a PRA will not be eligible to submit the EOI if it or any person acting jointly or in concert with it, is disqualified under Section 29A of the Code (as amended from time to time, including extant law/ regulations prevailing at the time of evaluation of eligibility criteria).

In case of a Consortium, each member of the Consortium should be eligible under Section 29A of the Code.

Each PRA, alongwith EOI, is required to furnish an undertaking in the form as set out in Annexure 'B' hereof confirming that it is not disqualified under Section 29A of the Code.

2. **REFUNDABLE DEPOSIT/ BANK GUARANTEE**

Along with the EOI, all PRAs shall be required to provide a non-interest bearing refundable deposit by way of Demand Draft/ Bankers Cheque/financial bank guarantee ("FBG" or "BG") or through such other instrument acceptable to the CoC, of INR 5 Lakhs ("**Refundable Deposit**")

The Refundable Deposit shall be paid through Demand draft in favour of Golden Glow Estates Pvt. Ltd. payable at par.

In case of FBG, an unconditional and irrevocable Financial BG from a bank should be issued in favour of Golden Glow Estates Pvt. Ltd with validity till nine (9) months, and to be extended for such additional time period as CoC/RP may decide until the expiry of CIRP. There will also be a 30 day claim period subsequent to last date of BG, allowed for invocation of the BG. The BG must be from a Scheduled Commercial Bank or a financial institution in India. The format of BG is attached as **Annexure- 'C'**.

The Refundable Deposit shall be refunded (without interest)/ the BG shall be returned within 30 days of the following:

- (a) Withdrawal of the PRA from the resolution plan process (where such withdrawal is notified to the Resolution Professional in writing) before submission of resolution plan;
- (b) PRA failing to submit the resolution plan by the due date as specified by the RP for submission of resolution plan;
- (c) The impact of any gains/ losses on account of foreign exchange fluctuation, if any shall be borne by PRA without any recourse to RP/Golden Glow/CoC.
- (d) Where the Resolution Plan submitted by the PRA is not approved by the CoC at its meeting held for that purpose.

3. **LAST DATE OF SUBMISSION OF EOI**

The last date for submission of EOI is March 21, 2019 ("**Last Date**"), (i.e Fifteen days from the date of publication i.e. March 06, 2019).

Note: Any EOI submitted after the Last Date shall not be considered.

Provided that the Resolution Professional may extend the Last Date, with approval of the CoC (at its sole discretion).

4. **SUBMISSION OF EOI**

The EOI should be unconditional and should be submitted in the format attached as **Annexure 'D'**. It should be accompanied with the following documents/ information:

- a. an undertaking by the prospective resolution applicant as specified under the Regulation 36A (7) of the CIRP Regulations, as per the format provided in Annexure 'A' and 'B'.

- b. For all PRAs - Profile of PRA including subsidiary (wholly-owned subsidiary and partly-owned subsidiary if any), promoter and promoter group, parent company and ultimate parent company and key managerial personnel.
- c. For all PRAs - Copies of Certificate of Incorporation/ Registration and Constitutional Documents (MoA, AoA) or other equivalent organizational documents. Copy of PAN card, GST number or equivalent documents as applicable.
- d. For all PRAs - Audited financial statements of the PRA for Financial Year 2015-2016, Financial Year 2016-2017, Financial Year 2017-2018 and/or its promoter/promoter group or any other group company as per eligibility criteria. In case of non-availability of the audited financial statements for the Financial Year 17-18, the provisional financial statement duly certified by the Management.
- e. For all PRAs - A notarized/apostle (as applicable) declaration from the PRA in order to demonstrate that the promoter/promoter group or any other group company are part of the same group, in case the interested party is using such entities for meeting the eligibility criteria. Please note that the PRA shall provide all relevant documents for its promoter/promoter group or any other group company, if required to meet the eligibility criteria.
- f. A set of Confidentiality Undertaking in the format attached as **Annexure 'D'**.
- g. A list of connected persons of the PRAs (including each member of the Consortium), as defined under Section 29A of the Code.
- h. A statement showing how the PRA meets the conditions laid down in the eligibility criteria along-with documents to substantiate the same including statement of disclosure giving details if the resolution applicant or any of its related parties has failed to implement or contributed to the failure of implementation of any other resolution plan approved by the adjudicating authority at any time in the past under the Code.
- i. In case of a Consortium, the relevant documents will need to be provided by each member of the Consortium.
- j. Any additional document/information asked by Resolution Professional or CoC must be furnished by PRA.

5. **CONSORTIUMS**

Where the EOI is being submitted by a consortium of joint bidders (“**Consortium**”), the EOI, along with all undertakings submitted pursuant to this EOI shall be signed by each member of the Consortium. Please further note that:

- a. a Person cannot be part of more than 1 (one) consortium submitting the EOI. Further a Person shall submit only 1 (one) EOI, either individually as a PRA or as a constituent of a Consortium;
- b. the Consortium shall submit the copy of duly notarized consortium agreement/MOU, if any, entered into between the Consortium members, setting out the respective obligations of the Consortium members;
- c. each member of the Consortium shall nominate and authorize a Lead Partner to represent and act on behalf of the members of the Consortium. Such Lead Partner shall be the single point of contact on behalf of the Consortium with the Resolution Professional and the CoC, their representative and advisors in connection with all matters pertaining to the Consortium;
- d. the members of the Consortium shall be jointly and severally liable in respect of obligations under the EOI/ undertakings given to the Resolution Professional;
- e. if any 1 (one) member of the Consortium is disqualified under Section 29A of the Code, then the entire Consortium; i.e., all the members of such Consortium shall stand disqualified;
- f. The EOI must detail the members of the Consortium, the Lead Member and the proposed percentage holding of each member ;
- g. Lead Member of the Consortium shall be identified at the time of submission of EOI and shall hold at least 51% stake in consortium with individual members not less than 20% ;
- h. No change of Lead Member or any member whose financials have been considered towards the eligibility criteria shall be permitted post submission of EOI (except with approval of the CoC subject to ensuring compliance with the eligibility criteria).

6. **IMPORTANT NOTICES**

- 1) CoC has the right to cancel or modify or withdraw the process of invitation of EOI or Resolution Plans without assigning any reason and without any liability. This is not an offer document and is issued with no commitment.

CoC has the right to amend this **Invitation for Expression of Interest** (hereinafter “**IEOI**”) or issue further supplements to the EOI or right to require additional documents from the PRAs without assigning any reason and without any liability. PRAs should regularly visit the web site at www.adellandmarks.com

to keep themselves updated regarding clarifications/ amendments/ time-extensions, if any.

- 2) It may be noted that the eligibility criteria for PRAs has been evolved in accordance with the provisions of the Code and CIRP Regulations. EOIs of only those interested parties who meet the eligibility and other criteria specified herein shall be considered. Resolution Professional/ CoC reserve their right to reject the EOI of any PRA and not include them in the provisional or final list of eligible PRAs in case:
 - (a) The PRA does not meet the eligibility criteria set out herein;
 - (b) If the EOI submitted by the PRA is incomplete or the PRA does not submit the documents as required under this IEOI or does not submit such further documents or information as requested by the Resolution Professional for conducting due diligence on the PRA;
 - (c) If any information/record provided is false, incorrect, inaccurate or misleading;
 - (d) If in the opinion of the COC, the PRA is undesirable or not credible or if the PRA fails to provide information, if requested, to establish its credibility, eligibility or ability to implement a resolution plan.
- 3) No oral conversations or agreements with the Resolution Professional or any official, agent or employee of the Resolution Professional, or any member of the COC, or any official, agent or employee of the Company shall affect or modify any terms of this EOI.
- 4) Neither the PRA nor any of representatives of the PRA shall have any claims whatsoever against the Resolution Professional or its advisors or any member of the COC or any of their directors, officials, agents or employees arising out of or relating to this EOI.
- 5) By submitting its EOI, each PRA shall be deemed to acknowledge that it has carefully read the entire **IEOI** and has fully informed itself as to all existing conditions and limitations. Ignorance of law/s will not be treated as any excuse.
- 6) The PRA acknowledges that the investment in the Company shall be made by the PRA on an “as is, where is” and “no recourse” basis and the RP or the COC will not be providing any representations or warranties for the Company.
- 7) All the EOIs received will be reviewed by RP in consultation with its advisors and CoC and a provisional list of eligible PRAs shall be shared in accordance with the Code and CIRP Regulations.

- (h) has executed a guarantee in favour of a creditor, in respect of a corporate debtor against which an application for insolvency resolution made by such creditor has been admitted

under the Code and such guarantee has been invoked by the creditor and remains unpaid in full or in part; and

That if, at any time after the submission of this undertaking and before the approval of the Resolution Applicant's resolution plan by the Adjudicating Authority i.e. Hon'ble National Company Law Tribunal under the Code, the Resolution Applicant becomes ineligible to be a Resolution Applicant as per the provisions of the Code (and in particular Section 29A of the Code), the fact of such ineligibility shall be forthwith brought to the attention of the RP and the CoC.
14. That this undertaking shall be governed in accordance with the laws of India and the National Company Law Tribunal, New Delhi /National Company Law Appellate Tribunal/ Courts of New Delhi shall have the exclusive jurisdiction over any dispute arising under this undertaking.

UNDERTAKING UNDER SECTION 29 OF THE INSOLVENCY AND BANKRUPTCY CODE, 2016 AND REGULATION 36(4) OF THE INSOLVENCY AND BANKRUPTCY BOARD OF INDIA (INSOLVENCY RESOLUTION PROCESS FOR CORPORATE PERSONS) REGULATIONS, 2016 TO MAINTAIN CONFIDENTIALITY

1. On 27th November, 2018, the Principal Bench of National Company Law Tribunal (“NCLT”) has directed commencement of corporate insolvency resolution process (“CIRP”) against **Golden Glow Estates Private Limited (“Golden Glow”)** under the Insolvency and Bankruptcy Code, 2016 (“IBC”). Mr. Udayraj Patwardhan, a licensed insolvency professional, was appointed as interim resolution professional of Golden Glow by the NCLT by order dated 27 November, 2018. He was later appointed as resolution professional (“**Resolution Professional**”) vide E-voting by the committee of creditors of Golden Glow Private Limited (“CoC”) in its meeting held on December 21, 2018.

2. On passing of the order dated 27th November, 2018 the powers of the board of directors of Golden Glow Private Limited stood suspended and the powers of its board of directors now vest in Mr. Udayraj Patwardhan.
3. It is the duty of the Resolution Professional under the IBC to prepare an Information Memorandum (“**IM**”) of the corporate debtor and invite the resolution applicants to submit a resolution plan.
4. Pursuant to the invitation for resolution plans from potential resolution applicants by the Resolution Professional, we are interested in submitting a resolution plan for Golden Glow Estates Private Limited to the Resolution Professional.
5. We require a copy of the IM of Golden Glow Estates Private Limited and other additional information relating to Adel and its subsidiaries that may be necessary to prepare a resolution plan of the Golden Glow Estates Private Limited by us, either directly or through our affiliates, for submission to the Resolution Professional. We note, understand and acknowledge that:

No representation or warranty, express or implied, is given by the Resolution Professional or the advisors appointed by the Resolution Professional or any of its partners, directors, officers, affiliates, employees, advisors or agents (unless specifically mentioned under the provisions of the IBC) as to the accuracy or completeness of the contents of this IM or any other document or information supplied, or which may be supplied at any time or any opinions or projections expressed herein or therein;
 - (iii) The IM is a dynamic document and may be updated from time to time till a resolution plan is approved by the CoC;
 - (iv) Other additional information relating to Golden Glow Estates Private Limited, Rational Buildcon Private Limited and Digamber Buildcon Private Limited and its parent company, i.e. Adel Landmarks Limited, may be necessary for preparing the resolution plan collectively and/or severally for each project;
 - (v) Any additional or supplementary information or clarification besides the IM, including those provided by way of emails or on telephone or in meetings provided to us by the Resolution Professional or his team members, including legal advisors are also confidential in nature and shall be construed as a part of the IM.

We will be solely responsible for any breach of the provisions of this undertaking of confidentiality by any of our Representatives.
9. We accept and acknowledge that the Confidential Information has been developed or obtained by Golden Glow Estates Private Limited through investment of significant time, effort and expense, and that the Confidential Information is valuable, special and unique asset of Golden Glow Estates Private Limited, which provides Golden Glow Estates Private Limited with a significant competitive advantage, and needs to be protected from improper disclosures. We further understand and accept that the information contained in the Confidential Information, as updated from time to time, cannot be used for any purpose other than for the Transaction. Accordingly, we unconditionally and irrevocably agree and undertake to ensure that our Representatives agree to:
 - (i) maintain confidentiality of the Confidential Information, as provided from time to time, and not to use such Confidential Information to cause an undue gain to themselves / us or undue loss to any other person including Golden Glow Estates Private Limited or any of its creditors and stakeholders;
 - (ii) keep the Confidential Information safe in a secure place and protected against theft, damage, loss and unauthorized access and undertakes to keep all documents and other materials reproducing or incorporating confidential information separate from its own confidential information;
