1. The application for Corporate Insolvency Resolution Process filed by M/s IL & FS Financial Services Limited (Financial Creditor) under Section 7 of the Insolvency and Bankruptcy Code, 2016 readwith Rule 4 of Insolvencyand Bankruptcy (Application to Adjudicating Authority) Rules 2016 was admitted by Hon'ble NCLT, Special bench, New Delhi vide order no. C.P. NO. IB- 1038(PB)/2018 dated 27.11.2018 wherein Mr. Udayraj Patwardhan, the undersigned was appointed as Interim Resolution Professional.
2. The Committee of Creditors at its first meeting held on December 21, 2018 had resolved and approved vide e-voting commenced on Tuesday December 25, 2018 and ended on Thursday December 27, 2018 with 100 percent Majority to continue Mr. Udayraj Patwardhan, Interim Resolution Professional as Resolution Professional.
3. In compliance with Regulation 13(2) of Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulation 2016, ("CIRP Regulations") a list of creditors along with amount claimed, claims admitted thereof and security interest in respect of such claims received up to December 14, 2019 was duly filed with this Hon'ble Tribunal.
4. As per Regulation 13 (1) of CIRP Regulations, List of creditors containing names of creditors along with the amount claimed by them, the amount of their claims admitted and the security interest, if any, in respect of such claims has been maintained, further updated for claims received upto February 20, 2019. The same was filed with this Hon'ble Tribunal.
5. The Hon'ble NCLT vide its Judgement dated August 06, 2019, in CA-918 (PB)/2019 stated that the Claim of Respondent No. i.e Edelweiss Asset Reconstruction Company Limited in the present Corporate Insolvency Resolution Process be set aside being a repetition of the claim which already stands admitted in other insolvency processes and consequently directed the Resolution Professional to amend the List of Financial creditors and to reconstitute the CoC accordingly.
6. In pursuance to the aforesaid, the list of creditors containing names of creditors along with the amount claimed by them, the amount of their claims admitted and the security interest, if any, in respect of such claims maintained, is further updated in view of aforesaid order and for claims received and verified and/or on receipt of additional



information warranting revision of list of creditors up to August 07, 2019 and is being filed with this Hon'ble Tribunal.

7. The verification of the claims has been based on the claims submitted and information provided by the creditors and information to the extent available with the Resolution Professional and has been admitted on the basis of our best estimate in accordance with Regulation 14 of CIRP Regulations.

Further, as the case may be, the undersigned shall revise the amounts of claims admitted, including the estimates of claims made, as soon as may be practicable, when he comes across additional information warranting such revision.

8. In compliance with Regulation 13(2)(d) of the CIRP Regulation, an updated List of Creditors along with amount claimed, claims admitted, security Interest in respect of claims received and verified and admitted upto August 07, 2019 is enclosed as **Annexure-A**
