Bhisham Infrastructure Private Limited (hereinafter "BHISHAM") is a private limited company registered under the provisions of the Companies Act, 2013 having its registered office at B-292, Chandra Kanta Complex, Shop No. 8, Near Metro Pillar No. 161, New Ashok Nagar, New Delhi-110096, India.

The Hon'ble NCLT, Principal Bench, New Delhi, vide its order dated 11.02.2020 has admitted petition for Manogayan Estates Private Limited., Bhisham Infrastructure Private

Limited and Superlative Infrastructure Private Limited under CIRP and ordered for consolidation of CIRP of these companies with its Holding Company i.e. Adel Landmarks Limited (undergoing CIRP).

It shall be pertinent to mention that as directed by the Hon'ble NCLAT and Hon'ble NCLT by their respective Orders, the CIRP Process for Adel Landmarks Limited ("Adel") i.E Holding Company and Mehak Realtech Private Limited ("Mehak"), Sachet Infrastructure Private Limited ("Sachet"), Sameeksha Estate Private Limited ("Sameeksha"), Magad Realtors Private Limited ("Magad") and Jamvant Estates Private Limited ("Jamvant") (Five Subsidiary Companies) is running jointly. Mr. Udayraj Patwardhan (IP Registration No.: IBBI/IPA-001/IP-P00024/2016-2017/10057) has been appointed as the Interim Resolution Professional ("IRP") of BHISHAM by the Hon'ble NCLT, Principal Bench.

[Further, the Committee of Creditors at its second meeting held on April 20, 2020 have vide e-voting concluded on April 27, 2020 approved to continue the appointment of IRP as Resolution Professional of the Corporate Debtor.]<sup>1</sup>

Pursuant to the provisions of Section 25(2) (h) of IBC, read with Regulation 36A of the CIRP Regulation, the IRP hereby invites Expression of Interest ("EOI") from interested and eligible prospective resolution applicants ("PRA") for the purpose of submission of Resolution Plan for BHISHAM.

It is pertinent to mention that Angad Infrastructure Pvt. Ltd., Trifalagagur Square Infrastructure Pvt. Ltd., Bhisham Infrastructure Pvt. Ltd. and Pawan Doot Estates Pvt Ltd. are separate owners of land in Sector 3-B, on which **Orchid Greens Project** is being developed by Adel (also, "Developer"), their holding company, pursuant to a Collaboration Agreement. CIRP pursuant to the Order dated May 10, 2019 passed by Hon'ble NCLT and it is understood that the Resolution Plan as approved bv the Committee of Creditors is filed before Hon'ble NCLT. Trifalagur Square Infrastructure Private Ltd. Bhisham Infrastructure Pvt. Ltd. is undergoing CIRP presently. Bhisham Infrastructure Private Limited currently undergoing CIRP pursuant to the Order dated February 11, 2020 passed by Hon'ble NCLT, and the Committee of has Creditors been constituted on March 7. 2020

- The eligible PRAs are invited to submit EOI for Bhisham. The PRAs may submit separate expressions of interest for other group companies undergoing CIRP, wherein separate Expression of Interest has been issued by the Interim Resolution Professional. It may be noted that last day for submission of Expression of Interest as per the Invitation in Form G in the matter of Adel Landmarks Limited and Five Subsidiary Companies was February 24, 2020.
- The CoC reserves the right to approve a resolution plan submitted only for Bhisham and/or other group companies., in accordance with law.

# ELIGIBILITY CRITERIA UNDER SECTION 25 (2) (h) of the CODE

To be eligible to submit EOI, the PRAs must satisfy the following eligibility criteria, as approved by the CoC in accordance with Section 25 (2) (h) of the Code.

# A. For PRAs that are Corporates- Private/ Public limited company, LLP, body corporate whether incorporated in India or outside India

- Minimum Tangible Net Worth ("TNW") INR.10,00,00,000/- (Rupees Ten Crore) at the Group Level in the immediately preceding completed financial year or;
- Net Worth shall be computed as aggregate value of paid-up share capital and all
  reserves created out of the profits and securities premium account, after
  deducting the aggregate value of the accumulated losses, deferred expenditure
  and miscellaneous expenditure not written off, and does not include capital
  reserves including reserves created out of revaluation of assets, write back of
  depreciation and amalgamation.
- For fulfilling the Group criteria, the entities shown as part of Group either must have controlling interest or controlled by or under common control with the PRA. Control means at least 26% ownership. The entities must have been part of the Group for at least 3 years.
- B. For PRAs that are Financial Investors- Foreign Investment Institutions (FII) / Mutual Funds / Private Equity/ Venture Capital Funds, Domestic/ Foreign Investment institutions, Non-Banking Finance Companies (NBFC), Asset Reconstruction Companies, Banks and similar entities
  - Minimum Asset Under Management ("AUM") or funds deployed of INR INR.100,00,00,000/- (Rupees Hundred Crore) in the immediately preceding completed financial year;

### C. For Consortium

PRA may be a Consortium. "**Consortium**" shall mean any person acting together with another person as a consortium/joint bidder or joint venture (whether incorporated or not) for the purpose of submission of the EOI and Resolution Plan for the Company.

Lead Member of Consortium Potential Resolution Applicant must satisfy eligibility criteria mentioned in Point "A" or "B" above, as applicable. In addition, Consortium should satisfy requirements set out in paragraph 6 below.

Each PRA, alongwith EOI, is required to furnish an undertaking in the form as set out in Annexure 'A' as per the requirement specified under Regulation 36A of the CIRP Regulations.

### 1. <u>DISQUALIFICATION UNDER SECTION 29A OF THE CODE</u>

Please note that a PRA will not be eligible to submit the EOI if it or any person acting jointly or in concert with it, is disqualified under Section 29A of the Code (as amended from time to time, including extant law/ regulations prevailing at the time of evaluation of eligibility criteria).

In case of a Consortium, each member of the Consortium should be eligible under Section 29A of the Code.

Each PRA, alongwith EOI, is required to furnish an undertaking in the form as set out in Annexure 'A' hereof confirming that it is not disqualified under Section 29A of the Code.

# 2. REFUNDABLE DEPOSIT/ BANK GUARANTEE

Along with the EOI, all PRAs shall be required to provide a non-interest bearing refundable deposit by way of Demand Draft/Bankers Cheque/financial bank guarantee ("FBG" or "BG") or through such other instrument acceptable to the CoC, of INR 2, 00,000/- (Rupees Two Lakhs) ("**Refundable Deposit**")

The Refundable Deposit shall be paid through Demand draft in favour of Bhisham Infrastructure Private Limited payable at par.

In case of FBG, an unconditional and irrevocable Financial BG from a bank should be issued in favour of Bhisham Infrastructure Private Limited with validity till twelve months, and to be extended for such additional time period as CoC/IRP may decide until the expiry of CIRP. There will also be a 30day claim period subsequent to last date of FBG, allowed for invocation of the FBG. The FBG must be from a Scheduled Commercial Bank or a financial institution in India. The format of FBG is attached as **Annexure-'C'**.

The Refundable Deposit shall be refunded (without interest)/ the FBG shall be returned within 30 days of the following:

- (a) Withdrawal of the PRA from the resolution plan process (where such withdrawal is notified to the Interim Resolution Professional in writing) before submission of resolution plan;
- (b) PRA failing to submit the resolution plan by the due date as specified by the IRP for submission of resolution plan;
- (c) The impact of any gains/ losses on account of foreign exchange fluctuation, if any shall be borne by PRA without any recourse to IRP/Corporate Debtor/CoC.
- (d) Where the Resolution Plan submitted by the PRA is not approved by the CoC at its meeting held for that purpose.

### 3. LAST DATE OF SUBMISSION OF EOI

The last date for submission of EOI is [Note-1] June 13, 2020 on or before 5:00p.m. ("Last Date").

Note: Any EOI submitted after the Last Date shall not be considered.

Provided that the Interim Resolution Professional may extend the Last Date, with approval of the CoC (at its sole discretion)

[Note-1]: Change in the timelines: To be read with Modified Form G dated May 26, 2020 hosted on the website of the Corporate Debtor i.e. http://www.adellandmarks.com/and on website of IBBI [First Form G published on March 22, 2020 in Financial Express and Jansatta [Both in Delhi & NCR edition] and further modified on April 06, 2020 and April 22, 2020 read with corrigendum to said modified Form-G dated April 29, 2020 further modified on May 14, 2020 hosted on the website of the Corporate Debtor i.e. http://www.adellandmarks.com/and on website of IBBI) inviting Expression of Interest from Prospective Resolution Applicant(s) w.r.t Corporate Debtor.

Further, the revision in the Timeline for submission of Expression of Interest is in view of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) (Third Amendment) Regulations, 2020, notification dated March 29, 2020, inserted new Regulation 40C, the relevant portion reads a "Notwithstanding the time-lines contained in these regulations, but subject to the provisions in the Code, the period of lockdown imposed by the Central Government in the wake of COVID-19 outbreak shall not be counted for the purposes of the time-line for any activity that could not be completed due to such lockdown, in relation to a corporate insolvency resolution process."

The Hon'ble NCLAT taking suo moto cognizance of the unprecedented situation arising out of spread of COVID19, passed the order dated March 30, 2020 interalia stating that the period of lockdown ordered by the Central Government and the State Governments including the period as may be extended either in whole or part of the country, where the registered office of the Corporate Debtor may be located, shall be excluded for the purpose of counting of the period for 'Resolution Process under Section 12 of the Code, in all cases where 'Corporate Insolvency Resolution Process' has been initiated and pending before any Bench of the National Company Law Tribunal or in Appeal before this Appellate Tribunal.

Thereafter, the Ministry of Home Affairs has vide its order dated May 17, 2020, has further extended the Lockdown to be continued till May 31, 2020, Accordingly, the last date for completion of CIRP stands as October 24,2020.

The above timelines are based on the Lockdown ordered till May 31, 2020. The same may be subject to further revision depending upon any further order/directions on Lockdown by the Government on account of pandemic COVID-19 read with Regulation 40C of CIRP Regulations.

### 4. **SUBMISSION OF EOI**

The EOI should be unconditional and should be submitted in the format attached as **Annexure 'D'**. It should be accompanied with the following documents/ information:

- a. an undertaking by the prospective resolution applicant as specified under the Regulation 36A (7) of the CIRP Regulations, as per the format provided in Annexure 'A' and 'B'.
- b. For all PRAs Profile of PRA including subsidiary (wholly-owned subsidiary and partly-owned subsidiary if any), promoter and promoter group, parent company and ultimate parent company and key managerial personnel.
- c. For all PRAs Copies of Certificate of Incorporation/ Registration and Constitutional Documents (MoA, AoA) or other equivalent organizational documents. Copy of PAN card, GST number or equivalent documents as applicable.
- d. For all PRAs Audited financial statements of the PRA for Financial Year 2017-2018, Financial Year 2018-2019, Financial Year 2019-20 and/or its promoter/promoter- group or any other group company as per eligibility criteria. In case of non-availability of the audited financial statements for the Financial Year 19-20, the provisional financial statement duly certified by the Management.
- e. For all PRAs A notarized/apostle (as applicable) declaration from the PRA in order to demonstrate that the promoter/promoter group or any other group

company are part of the same group, in case the interested party is using such entities for meeting the eligibility criteria. Please note that the PRA shall provide all relevant documents for its promoter/promoter group or any other group company, if required to meet the eligibility criteria.

- f. A set of Confidentiality Undertaking in the format attached as **Annexure 'E'**.
- g. A list of connected persons of the PRAs (including each member of the Consortium), as defined under Section 29A of the Code.
- h. A statement showing how the PRA meets the conditions laid down in the eligibility criteria along-with documents to substantiate the same including statement of disclosure giving details if the resolution applicant or any of its related parties has failed to implement or contributed to the failure of implementation of any other resolution plan approved by the adjudicating authority at any time in the past under the Code.
- i. In case of a Consortium, the relevant documents will need to be provided by each member of the Consortium.
- j. Any additional document/information asked by Interim Resolution Professional or CoC must be furnished by PRA.

# 5. **CONSORTIUMS**

Where the EOI is being submitted by a consortium of joint bidders ("**Consortium**"), the EOI, along with all undertakings submitted pursuant to this EOI shall be signed by each member of the Consortium. Please further note that:

- a. a Person cannot be part of more than 1 (one) consortium submitting the EOI. Further a Person shall submit only 1 (one) EOI, either individually as a PRA or as a constituent of a Consortium;
- b. the Consortium shall submit the copy of duly notarized consortium agreement/MOU, if any, entered into between the Consortium members, setting out the respective obligations of the Consortium members;

- c. each member of the Consortium shall nominate and authorize a Lead Partner to represent and act on behalf of the members of the Consortium. Such Lead Partner shall be the single point of contact on behalf of the Consortium with the Interim Resolution Professional and the CoC, their representative and advisors in connection with all matters pertaining to the Consortium;
- d. the members of the Consortium shall be jointly and severally liable in respect of obligations under the EOI/ undertakings given to the Interim Resolution Professional;
- e. if any 1 (one) member of the Consortium is disqualified under Section 29A of the Code, then the entire Consortium; i.e., all the members of such Consortium shall stand disqualified;
- f. The EOI must detail the members of the Consortium, the Lead Member and the proposed percentage holding of each member;
- g. Lead Member of the Consortium shall be identified at the time of submission of EOI and shall hold at least 51% stake in consortium with individual members not less than 20%;
- h. No change of Lead Member or any member whose financials have been considered towards the eligibility criteria shall be permitted post submission of EOI (except with approval of the CoC subject to ensuring compliance with the eligibility criteria).

### 6. **IMPORTANT NOTICES**

- 1) CoC has the right to cancel or modify or withdraw the process of invitation of EOI or Resolution Plans without assigning any reason and without any liability. This is not an offer document and is issued with no commitment.
  - CoC has the right to amend this **Invitation for Expression of Interest** (hereinafter "**IEOI**") or issue further supplements to the EOI or right to require additional documents from the PRAs without assigning any reason and without any liability. PRAs should regularly visit the web site at <a href="www.adellandmarks.com">www.adellandmarks.com</a> to keep themselves updated regarding clarifications/ amendments/ time-extensions, if any.
- 2) It may be noted that the eligibility criteria for PRAs has been evolved in accordance with the provisions of the Code and CIRP Regulations. EOIs of only those interested parties who meet the eligibility and other criteria specified herein shall be considered. Interim Resolution Professional/ CoC reserve their right to reject the EOI of any PRA and not include them in the provisional or final list of eligible PRAs in case:
  - (a) The PRA does not meet the eligibility criteria set out herein;

- (b) If the EOI submitted by the PRA is incomplete or the PRA does not submit the documents as required under this IEOI or does not submit such further documents or information as requested by the Interim Resolution Professional for conducting due diligence on the PRA;
- (c) If any information/record provided is false, incorrect, inaccurate or misleading;
- (d) If in the opinion of the COC, the PRA is undesirable or not credible or if the PRA fails to provide information, if requested, to establish its credibility, eligibility or ability to implement a resolution plan.
- 3) No oral conversations or agreements with the Interim Resolution Professional or any official, agent or employee of the Interim Resolution Professional, or any member of the COC, or any official, agent or employee of the Company shall affect or modify any terms of this EOI.
- 4) Neither the PRA nor any of representatives of the PRA shall have any claims whatsoever against the Interim Resolution Professional or its advisors or any member of the COC or any of their directors, officials, agents or employees arising out of or relating to this EOI.

- (iii) is or has been developed independently by us or our Representatives without reference to or reliance on the Confidential Information disclosed under this undertaking of confidentiality; or
- (iv) information was or becomes available on a non-confidential basis from a source that is not known by us or our Representatives to be prohibited from disclosing such information by any contractual, legal, or fiduciary obligation; or
- (v) prior consent by the Interim Resolution Professional is provided for disclosure in writing; or
- (vi) information that is required to be disclosed by us (to the extent required to be disclosed) by any applicable law for the time being in force or by any applicable regulatory authority or regulation or professional standard or judicial process, order of a judicial, regulatory or administrative authority (including by deposition, interrogatory, request for documents, subpoena, civil investigative demand, or similar process) or the guidelines of regulatory/administrative authority or stock exchange.
- 11. This undertaking also applies to Confidential Information accessed through the electronic data room and supersedes any 'click through' acknowledgement or agreement associated with any such electronic data room.
- 12. We agree to keep the Confidential Information safe in a secure place and protected against theft, damage, loss and unauthorized access and undertake to keep all documents and other materials reproducing or incorporating Confidential Information separate from our own confidential information.

We further hereby acknowledge and agree that in the event of breach or threatened breach of the terms of this confidentiality undertaking, the Interim Resolution Professional shall be entitled to all remedies available under law or equity.				
16. Nothing in this confidentiality undertaking shall have the effect of limiting or restricting any liability arising as a result of fraud or willful default.				
17. We hereby represent and warrant that we have the requisite power and authority to execute, deliver and perform our obligations under this confidentiality undertaking.
